Rules and Regulations

General Terms and Guidelines

- Pack-ur-Bags (PuB) is a full package travel provider which means we provide you all the services like accommodation, food, travel, VISA assistance (if applicable) and local sightseeing (as mentioned in respective trip/tours itinerary). PuB is a registered travel company which adheres to the general Package Travel and Package Tours regulations
- Prices are per person basis, which include VAT and local taxes, unless otherwise specified.
- Prices do not include passports and visa fees; baggage and personal insurance; beverages and food not listed under inclusions in the tour details. Any incidental / additional expenses incurred during the tour shall be borne by the participants, this includes expenses for food during travel by any mode of transportation, camera or like equipment charges, entry charges etc.
- PuB reserves all rights of admission for wildlife camp / trekking programme / any other programme announced by PuB.
- PuB reserves all rights to change the venue / dates / schedule / cost or cancel the tour.
- All the images captured during the camp/tour/outing will be PuB's property. However we understand and respect your privacy and will not post your images on our website or other public sites. We will keep them for our records only.

Bookings Guidelines and Agreement

- Booking for all the tours will be done on first come first served basis and will be made in person.
- The participants shall, along with the booking form, pay prescribed booking amount in advance.
- Participants registered online must pay the prescribed booking amount within one week of registration. In case of non-receipt of advance payment within one week, the registration shall be deemed to be cancelled.
- Balance payments (if any) shall be paid at least 15 days before the tour departure date. In case of non-receipt of advance payment within stipulated 15 days, the registration shall be deemed to be cancelled and cancellation charges as per cancellation rules will be applicable.

Cancellation Terms and Guidelines

- Any cancellation by participant(s) must be communicated to PuB in Office in writing in the prescribed format provided by PuB. The refund, if any, will be given after the tour is over, irrespective of the date when the cancellation has been communicated to us.

- In case of cancellation, 'refund amount' after deducting 'non-refundable costs' (such as Forest safari booking charges, Railway reservation and cancellation charges, Air ticket reservation and cancellation charges, Travel arrangements booking charges, Accommodation booking charges, handling charges) will be refunded after the tour is over, irrespective of the date when the cancellation has been communicated to us.
- Applicable Cancellation charges:
 - Cancellation done 60 days prior to departure – 90% refund
 - Cancellation done 45 days prior to departure – 65% refund
 - Cancellation done 20 days prior to departure – 25% refund
 - Cancellation done 9 days prior to departure or no show – No refund
 - In case the participant(s) have booked air tickets / railway tickets / bus tickets or hired a taxi in for the tour (or its extension), through us, then the refund paid by the airline authorities / railway authorities / bus operator / taxi operator shall be forwarded to the participants after deducting the processing charges.
 - PuB shall not be responsible for losses incurred for the air / train / bus bookings, or any extension to the tour camp, done by the clients, either independently or through us arising due to cancellation in the tour by PuB. In such cases, only the Amount accepted, as tour charges, will be refunded.

Your Responsibility

- You are responsible for your personal safety and for the safety of the accompanying people dependent on you. Please take time to understand and then confirm to the health and safety rules stipulated by the PuB team before the respective tour.
- During the tour, the participants shall abide by the instructions and decisions of PuB's representative.
- The participants must inform PuB of any medical ailments, disorders etc. (they might have) in advance at the time of booking for the tour.
- The participants also must inform PuB of any medical ailments, disorders etc. (they might have) during the tour. If the participants will have to take medical treatment from the doctor/ attendant available on the tour campsite or from the nearest available medical centre or hospital. The expenses for all medical treatment and arrangements for the same will be solely borne by the participant. In such events, the tour representative shall have complete discretion to continue the tour.
- It is a condition of our contract with you that you and all members of your party have suitable and sufficient travel insurance to cover your journey as PuB can't be held responsible for any liability, expenses or losses you incur as a result of being inadequately insured. We strongly recommend that at the time of booking a comprehensive travel insurance policy is purchased. PuB also provides you the optional insurance assistance for our domestic and international tours as a service (on chargeable basis). In case you wish to avail them, please let us know at the time of booking.

- You agree not to litter and disturb nature and wildlife during any of our trips. You should also adhere to the safety precautions explained by PuB representative. PuB is in no way obligated to complete a tour if one or more participants is found to be endangering the safety of themselves, others or the environment. Refunds will not be given in this situation.
- You agree to defend and indemnify PuB LLC and any of their officers, directors & employees from and against any claims, causes of action, demands, recoveries, losses, damages, fines, penalties or other costs or expenses of any kind or nature including but not limited to reasonable legal and accounting fees, brought by your violation of any law or the rights of a third party or your breach of this agreement.
- You agree to not smoke or drink (liquor, alcohol, hard-drinks) during any of our trips to avoid inconvenience to other members. PuB has a NO SMOKING and NO DRINKING policy for all of our trips. Your cooperation in this regard will be highly appreciated.

Our Liability to You

- It will be PuB's responsibility to review the description of hotel facilities, rooms, meals and other amenities to make the best decision for our travelers.
- During the tours, in case of any dispute (for whatsoever reasons), the decision of PuB' representative shall be final and binding on all the participants. In the event the participants disobey the directions / instructions, the participant(s) shall be solely liable for the risks, responsibilities and consequences
- In case of any injury, sickness, accident, death or any other casualty or loss or damage of valuables or luggage or any equipment; PuB, it's representatives, organizers, volunteers or any other person involved wholly or partially, either individually or jointly, shall not be responsible in any manner for the same and no claims of the participants, parents, guardians, relatives or friends of participants will be entertained.
- All adventure activities involve certain amount of risk due to inherent nature of these activities. PuB is committed to take all possible precautions to minimize the risks. However if the participants have enrolled for the activities like river rafting, rappelling, rock climbing, valley crossing, river crossing or any other adventure sports / activity, then all the risks and responsibilities related to and arising from such activities shall be solely upon such participants and PuB shall not be liable in any manner whatsoever.
- Disputes, if any, will be subject to Pune Jurisdiction only.
- In the event there is cancellation of tour due to force majeure / reasons beyond control of PuB, then no refund shall be payable.
